The 2023-2024 school year has already ended for some and for some the end is near. This year we had our federal CLASS review and our Focus Area 2 review. A big THANK YOU to everyone who participated in each review. Each staff person and parent showcased just how wonderful our program is. As everyone knows, we anticipate changes in the next school year. As we near these changes, my hope is that we embrace change and make the most of the wonderful wellness opportunities that our Agency has provided us.

Here are a few updates:

- The DCEA Board approved the 2.5% cost-of-living increase for 2024/2025. The increase should be effective July 1st or when you return.
- We will begin the 2024-2025 school year without Wearwood, Seymour, and Mentor Head Start. We anticipate serving 765 Head Start children and 72 Early Head Start children next year.
- We hope to be in the new Blount County facility next school year. This facility will become the home to 4 preschool classrooms. We are coming out of the Fairview, Lanier, Townsend, and Union Grove Head Start classrooms.
- We must get the required amount of attendance days and hours next year. Please pay close attention to the Head Start calendar when it is published on the website. There are changes in the dates that children will attend.
- Begining July 1st, our Agency will impliment shortened hours on Friday. Children will attend 4 hours on Fridays. If you do not know what your new work hours are, please speak with your area coordinator.
- All jobs will be posted on our website and indeed.com over the summer. Please check
 periodically for open positions. These positions will run for 3 days before interviews or transfers can
 take place.
- CPR & First Aid will be scheduled in July after all staff have returened to work. You will be notified if you are on the list to complete your certification when you return.

When you return, do not forget to check your classrooms for Health & Safety issues or concerns so we can correct them before children return. If you have concerns, complete a work order request or talk with your area coordinator or component manager.
